Parent Waiver and Release for the Use of Student Images and Student Work

I am the parent or legal guardian of the above named student. I have been informed that the Manhattan Beach Unified School District (“District”) and Distinguished Concerts International New York (“DCINY”) intend to take and utilize photographs in association with a concert to be held at Carnegie Hall on Sunday, May 29, 2016 (“Performance”), and that an unaffiliated third party approved by DCINY (“Approved Third Party”) intends to produce an archival recording of the Performance. I understand this activity may involve valuable learning experiences for my student and I agree to allow my student to participate in this activity or event as stated in this Waiver and Release.

I grant permission for the District, DCINY, and the Approved Third Party to photograph, video tape, and audio tape my child in connection with this Performance.

I hereby assign to the District, DCINY, and all of their current, former, and future agents, principals, representatives, and assigns, all rights, title and interest in, and to the use of my and my child’s image, likeness, voice, performance, written work, biographical information, and art through video, photographs, and any other media created by the District, DCINY, or the Approved Third Party in connection with the Performance (“the Media”), for any purpose..

I also authorize the District, DCINY, and their respective agents to use the Media for educational, organizational, and program or series publicity purposes. I further consent to any reproduction, copyright, exhibition, broadcast and/or distribution of the Media in whole or in part, without limitation or compensation.

I understand that my child’s participation in the Performance confers upon me and my child no rights to use, ownership or copyright of the whole or part of any materials created as part of the process of the Performance.

I also understand that I, my child, and my guests are prohibited from taking photographs or recordings of any part of the Performance, including the dress rehearsal/sound check, concert, and any other activity at Carnegie Hall.

I release the District, DCINY, and the Approved Third Party, and their employees, agents, and assigns from all liability that may arise from any and all claims by me or any third party in connection with my or my student’s participation in the Performance. I understand that neither I, my child, nor my family will be compensated for any use of the Media. I waive any right that I may have to inspect or approve the finished product or products or the editorial, advertising, or printed copy or soundtrack that may be

used in connection therewith and any right that I may have to control the use to which said product, products, copy and/or soundtrack may be applied.

I understand that the District has no control over non-District media sources and their use of my and/or my child's likeness, name, photograph, voice, or character, including any material gathered in connection with this Performance.

I hereby release and hold harmless the District from and against any claims that may arise regarding the use of my or my child's likeness, including but not limited to any claims of defamation, invasion of privacy, infringement of moral rights, rights of publicity or copyright. I agree to hold the District, its contractors, agents and employees harmless against any liability, loss or damage (including reasonable attorneys' fees) caused by or arising from the exhibition or telecast of my and/or my child's appearance in the Performance, or any utterance made by me and/or my child in connection with my and/or my child's participation therein.
